



ROAD TRAFFIC REGULATION ACT 1984

COMHAIRLE NAN EILEAN SIAR

**(DISABLED PERSONS' PARKING PLACES ORDER)
2018**

Comhairle nan Eilean Siar in exercise of its powers under the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act") and of all other powers enabling them in that behalf and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act of 1984 hereby making the following Order:

1. This Order may be cited as the "Comhairle nan Eilean Siar (Disabled Persons Parking Places) Order 2018 and shall come into operation on [Legal to insert date], notwithstanding the date hereof.
2. Subject to paragraph 3 below, no person may park any vehicle at any time, in a designated Disabled Persons' Parking Place as defined in Article 4 hereof.
3. Paragraph 2 of this Order shall not apply where the vehicle parked in a designated Disabled Persons' Parking Place is validly displaying a Blue Badge as defined in Article 4 hereof.
4. In this Order the following terms have the meanings ascribed thereto:
 - (a) "Blue Badge" means a badge issued in accordance with section 21 of the Chronically Sick and Disabled Persons Act 1970 or non-UK equivalent.
 - (b) "designated Disabled Persons Parking Place" means any space designated as parking for disabled persons, by virtue of this Order and as more particularly described in Parts 1 and 2 of the Schedule hereto.
 - (c) "vehicle" means any apparatus constructed for the carriage of persons, whether or not it is in a fit state for use on roads and includes any chassis or body with or without wheels, appearing to have formed part of a vehicle and any load carried by a vehicle and anything attached to a vehicle
5. The Comhairle nan Eilean Siar (Disabled Persons' Parking Places) Order 2013 is hereby revoked.

1	<i>Perceval Square Car Park, Stornoway, Isle of Lewis:</i> Three parking bays within Perceval Square Car Park, situated to the West of 20 Cromwell Street. The bays are at right angles to the northern boundary of the civic area and are marked as "No 1" on the Plan 1 annexed and subscribed as relative hereto (drawing No 19(6A30)02).	3
2	<i>Carn Gardens, South Beach, Stornoway, Isle of Lewis:</i> Three parking bays located three metres or thereby south of Carn Gardens within a layby and parallel to the carriageway of South Beach Street and bounded on the South by said carriageway and marked as "No 2" on the Plan 1 annexed and subscribed as relative hereto (drawing No 19(6A30)02).	3
3	<i>South Beach Car Park, Stornoway, Isle of Lewis:</i> Two parking bays situated within South Beach Car Park, adjacent and at right angles to the Northern boundary wall of said car park, opposite the premises at 21-23 South Beach Street and marked as "No 3" on the Plan 1 annexed and subscribed as relative hereto (drawing No 19(6A30)02).	2
4	<i>South Beach Street, Stornoway, Isle of Lewis:</i> One parking bay within the layby at 37 South Beach Street, situated parallel to the carriageway of South Beach Street and bounded on the South by said carriageway and marked as "No 4" on the Plan 1 annexed and subscribed as relative hereto (drawing No 19(6A30)02).	1
5	<i>Kenneth Street, Stornoway, Isle of Lewis</i> One parking bay situated on the West side of Kenneth Street, seven metres or thereby north of the junction with Francis Street. The bay is parallel to the footpath and marked as "No 5" on the Plan 1 annexed and subscribed as relative hereto (drawing No 19(6A30)02).	1
6	<i>North Beach Street, Stornoway, Isle of Lewis:</i> One parking bay at 7 North Beach Street. The bay is parallel to the footpath and is three metres or thereby from the Quay Street junction and marked as "No 6" on the Plan 1 annexed and subscribed as relative hereto (drawing No 19(6A30)02).	1
7	<i>Francis Street, Stornoway, Isle of Lewis:</i> One parking bay at 13 Francis Street. The bay is within a layby and is parallel to the footpath and marked as "No 7" on the Plan 1 annexed and subscribed as relative hereto (drawing No 19(6A30)02).	1

8	<p><i>South Beach Street:</i> One parking bay at 11 South Beach Street eight metres West or thereby of the Castle Street junction. The bay is within a parking area and is at right angles to and bounded on the South by the carriageway at South Beach Street and marked as "No 8" on the Plan 1 annexed and subscribed as relative hereto (drawing No 19(6A30)02).</p>	1
9	<p><i>Comhairle nan Eilean Siar Offices, Stornoway (South)</i> Four "off road" parking bays within the car park at the front of the Comhairle offices on Sandwick Road, Stornoway. The bays are located adjacent to the main entrance on the southern side of the Comhairle building and marked as "No 9" on the Plan 1 annexed and subscribed as relative hereto (drawing No 19(6A30)02).</p>	4
10	<p><i>Comhairle nan Eilean Siar Offices, Stornoway (North)</i> One "off road" parking bay within the car park at rear of the Comhairle offices on Sandwick Road, Stornoway. The bay is located adjacent to the rear entrance on the northern side of the Comhairle building and marked as "No 10" on the Plan 1 annexed and subscribed as relative hereto (drawing No 19(6A30)02).</p>	1
11	<p><i>Ionad Spòrs Leòdhais, Stornoway</i> Two "off road" parking bays within the car park on Sandwick Road, Stornoway adjacent to the main entrance of the Ionad Spòrs Leòdhais (sports centre) building and marked as "No 11" on the Plan 1 annexed and subscribed as relative hereto (drawing No 19(6A30)02).</p>	2

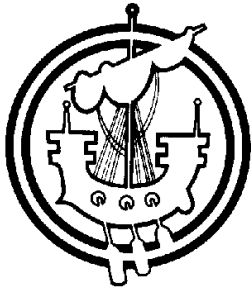

Notes to accompany the formal Order and not part of the formal Order

In the formal Order, descriptions of the bays are deliberately geographical rather than by reference to premises as presently occupied (eg "21-23" South Beach Street" rather than "the Clydesdale Bank". This is deliberate as occupants of premises can change relatively easily.

For ease of reference for the current proposals, noted below is information regarding the location of the bays, using current premises as landmark points. Reference should also be made to the location plan attached to the Order:
