# **CIVIC GOVERNMENT (SCOTLAND) ACT 1982**

## APPLICATION FOR A TAXI OR PRIVATE HIRE CAR DRIVER'S LICENCE

## (1) Who needs a licence?

Anyone who wants to drive a taxi or private hire car must first obtain a licence from the Comhairle. This licence has no connection with the driving licence issued by the Department of Transport.

### (2) Who is eligible?

Anyone can apply for a taxi driver's licence or a private hire car driver's licence if they have **held a full driving licence for a minimum period of 12 months**, under the Road Traffic Act 1988. If you do not, you must wait until the 12 months have passed before applying.

Additionally the Comhairle is entitled to decide whether any applicant is a fit and proper person to hold a licence.

If an application for a taxi/private hire car driver's licence is refused the applicant has a right of appeal against the refusal to the Sheriff.

#### (3) How do I apply?

An application form can be obtained from the Council Offices, Sandwick Road, Stornoway or the Council offices in Tarbert, Balivanich or Castlebay, or by writing to the Licensing Section, Chief Executive's Department at the Council Offices in Stornoway.

#### (4) How much will it cost?

£80 for a new taxi or private hire car driver's licence £60 to renew a current taxi or private hire car driver's licence

#### (5) Will I have to sit a knowledge test?

Yes. A date and time will be arranged for you to sit a written test. The test will include questions on general motoring and local knowledge of the area in which you intend to work.

#### (6) For how long will the licence be valid?

The licence, if granted, will usually be valid for a period of three years.

#### (7) Will I need a medical certificate?

The Comhairle, if it thinks fit can require an applicant for, or holder of, a licence to submit to a medical examination by a medical practitioner, usually the applicant's own medical practitioner, or if need be one nominated by the Comhairle.

Where an applicant or licence holder is over the age of 65 or where they have indicated to the Comhairle that they suffer from any physical or mental condition that affects their fitness as a driver, or which would do so in the future, then they will be required to attend a medical examination at their medical practice. The cost of the medical examination will be met by the applicant or the NHS or medical practice, if applicable. The current Council policy is that anyone attending an examination must satisfy the Group 2 (PSV) Standard. The Comhairle will not issue the driver's licence until we receive a report from the medical practice, and the following wording must be included in the report, "I certify that (insert name) meets DVLA Group 2 medical standards for driving".

The Group 2 (PSV) Standard applied by DVLA is also applied to any applicants for a taxi drivers' licence who require insulin treatment for diabetes, who must provide evidence

supporting C1 medical standards and should get a doctor's letter supplied by their medical practice stating that they are fit to drive.

#### (8) How long will it take to get the licence?

When you apply for a new licence, the licence cannot be granted before 28 days have lapsed from the date of the application being received by CNES. However, it usually takes an average of 6-8 weeks for an application to be processed.

#### (9) Can the application be refused?

Yes. The Comhairle can grant the licence with or without conditions or it may refuse to grant it.

The Comhairle **MUST** refuse the licence in certain circumstances including:

- (1) where the applicant has been disqualified by a Court from holding a licence;
- (2) where the applicant is not a fit and proper person to hold a licence;
- (3) where there is other good reason for refusing the application.

#### (10) Am I committing an offence if I do not obtain a licence?

Yes if you are conducting an activity which requires to be licensed in terms of the Comhairle's resolution and you do not obtain a licence then you are committing an offence and you will be liable, on summary conviction to a fine not exceeding £5000. If you obtain a licence and do not comply with a condition attached to the licence you will be guilty of an offence and liable, on summary conviction, to a fine not exceeding £2500. The Act provides that it shall be a defence for a person charged with an offence on non-compliance with a condition to prove that he used all due diligence to prevent the commission of the offence.

#### (11) What if I make a false statement on my application form?

If you make a statement which you know to be false or recklessly make any statement which is false, you will be guilty of an offence and liable, on summary conviction, to a fine not exceeding £5000.

Failure to disclose convictions is a criminal offence and any applicant failing to disclose a conviction will be reported to the Procurator Fiscal with a view to prosecution.

#### (12) Are there any other offences arising from the operation of the licensing system?

Yes.

- (a) if you fail without reasonable excuse to notify the Comhairle of a material change of the circumstance of your licence then you may be liable to a fine of £2500.
- (b) if you fail, without reasonable excuse to return your licence to the Comhairle after it has been revoked or after you cease to conduct the trade or business for which the licence was issued then you will be liable on summary conviction to a fine not exceeding £500.

#### (13) Immigration Act

Under the provisions of the Immigration Act 2016 which came into force on 1 December 2016, the Council will be unable, from that date, to grant a taxi driver or private hire car

(PHC) driver licence unless a face-to-face check has first been made to verify that the applicant is not disqualified by reason of his or her immigration status from driving a taxi or private hire car.

This means that **all applicants for taxi or PHC driver licences**, including UK passport holders, will **require to attend their nearest licensing office in person with original documents** (e.g. **passport** or **other acceptable documents**) demonstrating that they have the right to work in the UK.

This checking process is required for all current new applications and renewal applications. If you produce a document from list A below, you will not need to produce the document again when you apply to renew your licence, as long as your immigration status does not change.

Licensing staff will be required to check the validity of the original documents in the presence of the applicant before the licence can be issued. The Council is required by law to retain copies of these documents.

(Please note that this checking process under the Immigration Act 2016 is in addition to the criminal history check which the Council carries out with Police Scotland for each applicant to determine the applicant's fitness to hold a licence.)

If necessary, the Council may pass your details to the Home Office in order to make further enquiries regarding your immigration status and right to work in the UK. In addition, the Home Office may request that we supply them with copies of your documentation in relation to immigration and right to work enquiries.

Applicants who cannot produce the necessary evidence should be aware that their details may be passed to the Home Office and that the Home Office may also pass your details to other Government bodies such as the DVLA in relation to immigration matters.

## (14) **HMRC Tax Check**

The rules for completing a tax check changed on 2 October 2023 in Scotland. You may need to complete a tax check yourself on the webpage <u>Complete a tax check for a taxi</u>, <u>private hire or scrap metal licence - GOV.UK (www.gov.uk)</u> to confirm that you are registered for tax if you're applying for a renewal of a taxi or private hire car driver licence.

**Renewal application** - The new rules mean you **must complete a tax check** if you're:

• renewing a taxi or private hire car driver licence or applying for the same type of licence you previously held, that stopped being valid less than a year ago.

After you complete the tax check you'll be given a 9-character code. This is your tax check code. You **must give it to CNES with your licence application** — we will not be able to **process your application without it.**
