DRAFT ANTI-SOCIAL BEHAVIOUR ACTION PLAN 2024-29

Report by Chief Social Work Officer

PURPOSE

- 1.1 The purpose of the Report is to update Members on the current position on the Comhairle's response to reported incidents on anti-social behaviour.

EXECUTIVE SUMMARY

- 2.1 Following a number of representations to Members from constituents relating to actual or alleged incidents of anti-social behaviour in Stornoway (other areas of the Outer Hebrides can be affected by anti-social behaviour also, only to a lesser extent) it was decided to review the Anti-Social Behaviour Action Plan. A Report to the Community Safety Board in September 2024 indicated that the Comhairle would review and update the Anti-Social Behaviour Strategy.

 - (a) **note the Draft Anti-Social Behaviour Strategy and Action Plan 2024-2029; and**
 - (b) **note the intention for further partnership and community consultation in respect of the Draft Anti-Social Behaviour Strategy and Action Plan 2024-2029.**

BACKGROUND

- 5.1 Local agencies – local authorities, Police Scotland, the children’s hearing system, the courts and registered social landlords – need to work together to tackle antisocial behaviour. They also need to work closely with local people, because they are the ones who experience anti-social behaviour, and they need to be involved in developing the solutions. Anti-social behaviour strategies, covering each council area in Scotland, provide the basis for promoting co-ordinated action to prevent and tackle anti-social behaviour in local communities.
- 5.2 The Comhairle aspires to deliver a high standard and quality service to all clients involved in antisocial behaviour, both to the complainant and the alleged offender. The revised Anti-Social Behaviour Strategy, when implemented should help people within the community to understand the role the Comhairle and partner agencies have in helping prevent and resolve disputes and tackling anti-social behaviour.
- 5.3 The Comhairle’s current anti-social behaviour policy and procedure dates back to 2012 and due to certain services referenced within the policy and procedure it no longer remains relevant. The Community Planning Partnerships Anti-Social Behaviour Strategy dates back to 2013 - 2017. The Comhairle continue to comply with the policy and procedures although given the reduced resources available, the method of service delivery may vary, with there being a need for a renewed Action Plan.
- 5.4 The National Anti-Social Behaviour Working Group recognises that anti-social behaviour root causes come from mental health, drugs and alcohol, poverty, housing, etc. Nationally, there is a rethink on what approaches are taken to address Anti-Social Behaviour. There needs to be a multi-agency and multi-strategy response.

DETAIL

- 6.1 Until such time as the updated Anti-Social Behaviour Action Plan is agreed and then implemented, any incidents of anti-social behaviour, where the alleged perpetrator or victim is under 18 years of age, should be directed towards Children's Services. Depending on the severity, nature and who happens to be involved in that child's life at the time, either Education or Social Work will follow up on the concerns.
- 6.2 Where the alleged perpetrator is over 18 and known or suspected to be a HHP tenant, then the complainer should be redirected to HHP.
- 6.3 Where the alleged perpetrator is over 18 and known or suspected to be in privately rented accommodation or an owner occupier or lives in an owner occupied home i.e. adult son or daughter of owner occupier, then the complainer should be referred on to Environmental Health who will triage the referral and either respond to directly or redirect to other services, depending on the nature of the referral.
- 6.4 Where the alleged perpetrator is age 18 or over, and the act is a crime, then the complainer should be redirected towards Police Scotland. All reports of incidents, whether crime related or not, will result in the creation of an incident report which is auditable; Following initial registration, an incident will be recorded as a crime in all cases if:
- the circumstances amount to a crime defined by Scots Law or an offence under statute; and
 - there is no credible evidence to the contrary
- 6.5 The draft Anti-Social Behaviour Strategy and Action Plan 2024 – 2029 is now at a stage where the wider community planning partnership has contributed to the consultation in addition to the consultation about to be embarked upon with community groups.
- 6.6 The actions contained within the draft Strategy broadly reflect the types of anti-social behaviour experienced locally but also largely reflect what is happening elsewhere in Scotland.

CONCLUSION

- 7.1 The Anti-Social Behaviour Strategy and Action Plan 2024-2029 is now at a stage to consult with the wider planning partnerships and with community groups. Further discussions are planned in terms of how best to undertake the wider consultation process. The intention is that early in 2025 consultation events and activities will be underway.
