| Licensing Update | 4 | With reference to the Item 4 of Minute of Meeting of 22 September 2022 the Chief Officer, Assets and Infrastructure submitted a Report seeking approval for an update of the Short-Term Let Licensing Scheme Policy and fees and other licensing fees and procedures. The Report stated that the Comhairle had implemented a Short-Term Let Licensing Scheme on 1 October 2022 and had processed and issued over 1000 applications and licences. Based on the issues and experiences on implementing the scheme it was proposed that the Short-Term Let Licensing Policy and fees be updated in line with the revised policy detailed in the Appendix to the Report. |
