Report

The Chief Officer, Assets and Infrastructure submitted a Report presenting the half-year progress of the 2024/25 Departmental Strategic Priorities for the Assets and Infrastructure Business Unit detailing an update on the departmental key areas of strategic risk, progress on the strategic outcomes and the resources identified to implement the Business Plan. The Report further detailed financial performance and progress on departmental workforce planning.

The Report stated that the Business Plan was aligned to all four strategic priorities and progress on the outcome delivery plans were detailed in the body of the Report. The Report concluded that the Assets and Infrastructure Business Unit had maintained good controls on business planning, governance, and budget management the first two quarters of 2024 / 25. With reference to item 4 of the Minute of Meeting of 12 June 2024, Area Commander Chief Inspector Jane Mackenzie submitted a Report summarising current performance against the 2023-2026 Comhairle nan Eilean Siar Local Policing Plan objectives covering the period 1 April 2023 to 1 June 2024. Draft Anti-Social Behaviour Action Plan 2024 – 2029

With reference to item 5 of the Minute of Meeting of 18 September 2024 the Head of Children’s Services/Chief Social Work Officer submitted a Report providing an update on the current position on the Comhairle’s response to reported incidents on anti-social behaviour. The Report stated that, following a number of representations to Members from constituents relating to actual or alleged incidents of anti-social behaviour in Stornoway (other areas of the Outer Hebrides can be affected by anti-social behaviour also, only to a lesser extent), it was decided to review the Anti-Social Behaviour Action Plan.

The draft Anti-Social Behaviour Strategy 2024-2025 was detailed at Appendix 1 to the Report and was now at a stage to consult with the wider planning partnerships and with Community Group. Further discussions were planned in terms of how best to undertake the wider consultation process with the intention that consultation events and activities would take place in early 2025.

- (2) **note the intention for further partnership consultation and for wider community consultation.**
