Representation to a Private Hire Car Driver's Licence Application	3*	The Chief Executive submitted a Report in relation to an application for a Private Hire Car Driver's Licence by applicant AB. The Report stated that the licensing authority had received a representation to the application from Chief Superintendent Rob Shepherd, Police Scotland dated 13 June 2024. Applicant AB had been subsequently contacted to confirm that they had received the Police Scotland representation letter and they acknowledged that the matter would be considered by the Civic Government Licensing Panel.
		The Panel were informed that the applicant would not be attending the meeting.

Sgt Sarah Paterson, representing Polce Scotland was invited into the meeting and was given the opportunity to address the Panel in relation to the representations to AB's application. The Panel were afforded the opportunity to ask questions.

Sgt Paterson withdrew from the meeting while the Panel deliberated.

Having considered the Report together with the representations from Police Scotland, the Panel agreed to refuse the application for a Private Hire Car Driver's licence because, taking into account the nature of the applicant's conviction, the Panel are of the view that they are not a fit and proper person to hold a Private Hire Car Drivers' licence.

that they had received the Police Scotland representation letter and they acknowledged
that the matter would be considered by the Civic Government Licensing Panel.

Sgt Sarah Paterson, representing Polce Scotland and applicant CD were invited into the meeting and were given the opportunity to address the Panel in relation to CD's application for a Taxi Driver's Licence. The Panel were afforded the opportunity to ask questions. Both parties were given the opportunity to sum up.

Having considered the Report together with the representations from Police Scotland and applicant CD, the Panel agreed to refuse the application for a Taxi Hire Car Driver's licence because, taking into account the nature of the applicant's convictions and the misrepresentation of a conviction by applicant CD, the Panel are of the view that they are not a fit and proper person to hold a Taxi Hire Car Drivers' licence.

Panel.

The Panel were afforded the opportunity to ask questions. Both parties were given the opportunity to sum up.

Having considered the Report together with the representations of applicant EF and Police Scotland, the Panel agreed to approve the application for a Taxi Drivers's licence.
