## **BUSINESS CONTINUITY PLANS**

Report by Chief Executive

#### **PURPOSE**

1.1 The purpose of the Report is to update Elected Members on the status of Business Continuity Plans across the Comhairle.

#### **EXECUTIVE SUMMARY**

- 2.1 The Corporate Strategy 2024-2027 sets the strategic direction of the Comhairle, and the Service Business Plans (SBPs) demonstrate how this will be achieved. Operational Risk Registers identify risks and control actions, to increase the probability of success and reduce the likelihood of failure
- 2.2 Risks that result in a disruption to service, require continuity strategies to allow service delivery to continue with minimum disruption. Services are asked to prepare a Business Continuity Plan (BCP) for their most critical activities, therefore in the event of an incident that causes disruption, the BCP can be picked up and immediately actioned.
- 2.3 A Business Continuity Plan folder is available on SharePoint where Elected Members can view the most recent documents. The first step of the Business Continuity process is the Business Impact Analysis (BIA) which determines whether a BCP is required. Where the BIA determines that a BCP is not essential to the service, the BIA will be available to view.
- 2.4 The Corporate Business Continuity Plan shall be updated and reported to the next Committee series in June 2025.
