LEABHARLAINN NAN EILEAN SIAR STRATEGY 2025-27

Report by Chief Officer Education and Children's Services

PURPOSE

The purpose of the Report is to seek approval to proceed to formal consultation on the Leabharlainn 1.1 na Eilean Siar Strategy 2025-2027.

EXECUTIVE SUMMARY

- 2.1 Leabharlainn nan Eilean Siar provides services across our islands delivered through our network of four branches and two mobile library vans.
- 2.2 As a statutory service tasked with providing library facilities for all person's resident in the Western Isles it is vital that the service has a focus on both national and local priorities as set out in the Local Outcome Improvement Plan, the Comhairle's Corporate Strategy and in Scotland's Public Library Strategy. In order to ensure this focus the Service has developed a draft strategy (Appendix 1) and is seeking approval to proceed to formal consultation on the strategy. A proposal for Community Consultation is set out in Appendix 2. It is proposed that the Comhairle consider the re-establishment of the Library Member Officer Working Group to support the development of the strategy. In the interim the service has prepared a one-year Action Plan to deliver on identified priorities (Appendix 3).
- 2.3 The Service is currently working on an Annual Report setting out key achievements in the past year. Highlights are included in the draft strategy and the finalised Annual Report and will be uploaded to the website when complete.

 - approve formal consultation on the draft Leabharlainn na Eilean Siar Strategy 2025-27; (a)
 - (b) re-stablish the Library member Officer Working Group to support the development of the
