Comhairle nan Eilean Siar Budget Proposals 2025/26: Public Feedback Summary

136 members of the public submitted responses to the Comhairle's budget feedback form.

The feedback form was opened to members of the public on Thursday 13 February and promoted on the Comhairle's social media, website and the local press.

Members are thanked for their assistance in promoting the feedback form and encouraging public engagement.

Respondents to the form were asked to answer three questions giving their view on the Comhairle's budget proposals.

A summary of responses is detailed below.

Question: What Comhairle services are most important to you and should be protected from service reductions?

In response to this question members of the public selected a variety of services. Health and Social Care scored highest with particular mentions for the importance of home care services.

Education was deemed to be the next most important service area followed by roads and library services.

Across several responses there was a feeling that the delivery of services within local areas was important and that centralisation to Stornoway should be avoided.

Question: Do you have any additional feedback on the Comhairle's budget proposals?

In response to this question members of the public provided a variety of feedback on the Comhairle's budget proposals.

Council Tax and the use of Crown Estate funds were two issues that featured in a significant number of responses with a variety of opinions shared.

32 members of the public felt that an 8% increase in Council Tax was too high. 7 respondents either agreed with the increase or suggested that the increase should be higher. A further 4 respondents called for a review of Council tax bands either based on updated property values or with consideration for the levels of Comhairle services delivered in geographical areas.

The rest of the responses suggested a variety of potential service reductions that are listed below.

What capital projects should Comhairle nan Eilean Siar look to progress as a priority?

Respondents listed road resurfacing as the priority capital project. Responses on roads ranged from the general condition of roads to specific examples of geographic areas in need of attention.

The Comhairle's priority capital project the Barra and Vatersay Community Campus (BVCC) came in next with particular mention for the replacement of Castlebay School. While not a matter for the Comhairle's budget 9 respondents singled out the hospital aspect of the project as a priority. This is included below for information.

In addition to the mention of Castlebay School 7 respondents called for new school buildings in different areas.
