This budget saving proposal involves relocating the Children and Families Team, Lewis and Harris, from St Lennans to Sandwick Road. Discreet meetings are now possible through Microsoft Teams and Scottish Children's Reporters Administration (SCRA) have offered their premises to be used two days per week. This is expected to achieve savings of £20k which is 0.5% of the budget available for this section within the Education, Skills and Children's Services Department.

Detail the budget implication relating to the policy:

This proposal aims to save £20,000 per annum. This equates to a saving of 0.5% of the total budget.

What will change as a result of this policy?

The relocation of employees from St Lennans back to Sandwick Road would have no identified impacts. The benefits of St Lennan's were that it provided a more discreet meeting place than could be offered at Sandwick Road. This has been mitigated now with the introduction of Microsoft Teams and the use of SCRA facilities.
