### **Introduction**

This is an application form for relief available under The Non-Domestic Rates (Islands and Remote Areas Hospitality Relief) (Scotland) Regulations 2024, under which 100% relief is available for the 2024-25 financial year, capped at £110,000 per ratepayer.

Ratepayers are required to make a declaration (see section 2 of this form), to ensure that they do not exceed £110,000 of this relief award. The Comhairle will reclaim any relief incorrectly awarded on incomplete, incorrect or fraudulent information.

The list of whole or main property uses that may be eligible for relief are:

- Bed and breakfast accommodation
- Camping site
- Caravan
- Caravan site
- Chalet, holiday hut and bothy
- Guest house, hotel and hostel (where no significant element of care is provided)
- Public house or nightclub where the following conditions are satisfied
  - o a premises licence authorising the sale of alcohol for consumption both on and off the premises has been issued by a licensing board under section 26 of the Licensing (Scotland) Act 2005(3)
  - o the premises are used for such sales to members of the public, principally for consumption on the premises, in accordance with the operating plan contained in the premises licence, and
  - the operating plan contained in the premises licence does not include any provision that such sales are made subject to those members of the public residing at, or consuming food on, the premises.
- Restaurant, café, coffee shop, bistro, fast food restaurant or snack bar used for the sale of food or refreshments to members of the public for consumption on those premises
- Self-catering holiday accommodation
- Timeshare accommodation

### 3. Subsidy Rules under the EU-UK Trade and Cooperation Agreement (TCA)

Hospitality relief is likely to be deemed a subsidy and therefore capped at a maximum of 325,000 euros Special Drawing Rights (around £340,000 as at January 2022, although exact amount will fluctuate) over a combined three-fiscal-year period (i.e. measured per accounting year of the ratepayer).

You must consider whether you have already received support from any public sector body in your current and previous two accounting years.

To ensure that the Comhairle complies with the subsidy regime, it may be required to cap this relief. This will depend on the level of other public sector assistance received by you in this, and the past two fiscal years including non-domestic rates relief on this and any other property that you have an interest in the UK (NOTE: this may include certain COVID-19 grant schemes. However, not all grants are considered to be capped in this way. The Comhairle will determine this from your completed Subsidy and Aid Information Form).
