#### **1. Welcome new members**

#### **2. Matters Arising:**

Discussion about the constitution, and the changes that could be made.

**ACTION:** JF to send copy of constitution for approval at our next meeting.

#### **3 New Members**

It was agreed to increase NUCC membership by 10 , to approach people and also to advertise; thinking closely about community stakeholders. UR mentioned including those that have certain expertise that could benefit the community council.

**ACTION:** All to consider people to ask and how to advertise.



#### **4. Area Forum**

MH & UR suggested the formation of an area forum .Discussion was had that North Uist is a very large area for one community council to cover there are other Community Councils covering a much smaller area. We are often approached by the community with similar issues and it may would be worth creating an area forum with NU and Berneray.MH didn't want NUCC to become a platform to complain.

#### **5. NUBLPP**

With new community council members, JF felt it was time to familiarise with North Uist & Benbecula Locality Planning Partnership, and what they do. What has been achieved for North Uist?

Since forming NUBLPP the ward boundaries have changed . NUBLPP have been unable to recruit a development worker since Jemma MacVicar left. MH suggested that it may be possible to secure a share of the funding which was allocated to the NUBLPP development workers post to potentially employ a development worker solely for North Uist & Berneray.

**ACTION:** MH and JF to look into this further.

#### **6. Office Bearers**

It was agreed by all that the office bearers would change annually. NJ suggested assigning things amongst everyone to ease the pressure.
