The Arts Grants totalling £94k have been used for many years to support both the two main RFO's (Regularly Funded Organisations as described by Creative Scotland and music festivals, Feisean and the Ceolas summer school. An Lanntair, being the largest of the RFO's receives about half of the annual funding and Taigh Chearsabhagh £13k. The remaining budget is distributed to Heb Celt, EDF music festivals, 7 local Feisean and Ceolas.

It is proposed to remove the core Comhairle budget but to explore alternative sources of funding. This will ensure that there is no impact on the arts organisations.

There will be no changes if an alternative funding stream is provided.
