ROAD TRAFFIC REGULATION ACT 1984

TEMPORARY ROAD CLOSURE (CROMWELL STREET, NORTH BEACH STREET, CASTLE STREET, POINT STREET, FRANCIS STREET, BANK STREET, STORNOWAY) ORDER 2024

Comhairle nan Eilean Siar, under section 16A of the Road Traffic Regulation Act 1984, as amended, hereby make the following Temporary Traffic Regulation Order:

- 1. This Order may be cited as the "Comhairle nan Eilean Siar Temporary Road Closure (Cromwell Street, North Beach Street, Castle Street, Point Street, Francis Street, Bank Street, Stornoway) Order 2024".
- 2. Subject to Article 3 hereof, no person shall drive or cause to be driven any vehicle on Tuesday 26 November 2024 between the hours of 6.15pm and 8.30pm on:

CROMWELL STREET – from the Bayhead Street/Kenneth Street junction and then in a southernly direction to South Beach Street.

NORTH BEACH STREET - from Cromwell Street and then in in a westerly direction to Castle Street.

CASTLE STREET (WEST LANE ONLY) – from South Beach Street and then in a northerly direction to North Beach Street.

POINT STREET/ FRANCIS STREET - from Castle Street and then in an easterly direction to Kenneth Street.

BANK STREET – from South Beach Street in a northerly direction to North Beach Street.

A plan showing the roads affected, highlighted in red, is annexed and executed as relative hereto.

3. Access will be available for emergency service vehicles in discharge of their duties.

Traffic will be held up at any junctions or accesses to the sections of road affected by the closure.

The temporary road closure is in the interests of road safety for the duration of the Christmas lights event in Stornoway.


